Jade's Grandmother stated that she has a hard time getting Jade to eat and she is losing weight. Jade's Teachers are concerned because Jade is falling behind in her school work. Jade is however continuing counseling and working on coping strategies. Jade has been working one-on-one with a co-worker learning more about types of grooming skills. Jade (out of the blue) has expressed interest in wanting a job at Wal-Mart. Took Jade to Wal-Mart, she wanted to work in the pet section. Arranged for Jade to job shadow in the pet section at Wal-Mart.
